

Ordinance No. 1977-2

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BROWNSDALE, TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated the 12 day of April 1977, requesting annexation of the territory hereinafter described was duly presented to the council on the 22 day of April 1977; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 0 acres of platted land, no part of which is included within the limits of an incorporated city, or borough; and

WHEREAS, the petition was signed by Louis Streightiff and Margaret Streightiff, the sole owners; and

WHEREAS, sixty (60) days have passed since the original filing of the Petition for Annexation with the City of Brownsdale; and

WHEREAS, sixty (60) days have passed since the filing of copies of said Petition to Annex with the Minnesota municipal commission, the Red Rock Town Board and the Mower County Board; and

WHEREAS, there is no other municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, no objections to the annexation have been received from the Town Board of Red Rock Township, whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the west boundary thereof;

The council of the City of Brownsdale, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts

upon the city limits and is urban or suburban in character; and
(3) that none of said territory is now included within the limits
of any city, or borough.

Section 2. Territory Annexed. The corporate limits of the
city are hereby extended to include the platted land described as
follows and the same is hereby annexed to and included within the
city as effectually as if it had originally been a part thereof:

That part of Outlot 49 in Section 9, Township 103, Range 17,
Mower County, Minnesota, described as:

Beginning at an in-place 3/4 inch diameter iron pipe monument
located on the south line of Main Street (north line of Outlot
49) 1024 feet west from the northeast corner of Block 3, Village
of Brownsdale; thence West 116.00 feet along the south line of
Main Street; thence south at a right angle 297.00 feet; thence
east at a right angle 216.00 feet; thence north at a right angle
176.83 feet, thence west at a right angle 100.00 feet; thence
north at a right angle 120.17 feet to the place of beginning.

Section 3. Filing. The city clerk is hereby directed to file
certified copies of this ordinance with the Minnesota Municipal
Commission, the Secretary of State, the Town Clerk, and the County
Auditor.

Section 4. Effective Date. This ordinance takes effect upon
it's passage and publication and the filing of the certified copies
as directed in Section 3.
